The project title is: **SUPPLY AND DELIVERY OF PASTEURIZED FRESH MILK FOR THE DEPED SCHOOL-BASED FEEDING PROGRAM – MILK COMPONENT FOR SDO ALBAY AND CAMARINES SUR PROVINCE** and the procuring entity is **NATIONAL DAIRY – SOUTH LUZON DEPARTMENT**

Also, based on the results of the Pre-Bid Conference which was conducted on 27 July 2021 from 1:30 PM to 2:30 PM via videoconference (Webex Cisco), the following requirements were clarified accordingly:

- Bidding documents will be available at the new office NDA South Luzon Department. Interested bidders are advised to pay the tender documents personally or through an authorized representative (no official payment transaction portal at the moment).

Based on the discussions of the Section VI. Schedule of Requirements and Section VII. Technical Specifications, the following requirements were clarified accordingly and upon the recommendation of the TWG:

- Double Feeding is not allowed
- Only the 200ml pouch will be used as packaging of milk to be delivered.

All interested bidders should submit Audited Financial Statement for CY 2019 and 2020. Bidders should also submit two copies of all requirements (original and photocopy).

Documents should be properly labelled and tagged. All erasures should be countersigned.

For the SDO of Albay, all schools and beneficiaries are from Guinobatan, Albay.

As recommended, delivery will be at 1-2 drop off points per batch/lot.

All other documents stated in Section VII should be submitted during post qualification.
