RESOLUTION No. 4-28-2 28 April 2021

REF: SUPPLY AND DELIVERY OF 55,800 1LITER BOTTLES OF PASTEURIZED FRESH MILK FOR THE IMPLEMENTATION OF THE MILK COMPONENT OF THE 2020 SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR THE DIVISION OFFICES OF THE CITY OF MARIKINA

WHEREAS, the National Dairy Authority (NDA) signed a memorandum of agreement (MOA) with the Department of Education – City Division Office of Marikina City, for the implementation of the School-Based Feeding Program (SBFP)- Milk Component of Republic Act 11037, the *Masustansyang Pagkain Para Sa Batang Pilipino* Act;

WHEREAS, Section 4(ggg) of RA No. 11494 (*Bayanihan* 2) provides that the provision of access to free, healthy meals as mandated by RA 11037 or the "Masustansiyang Pagkain Para sa Batang Pilipino Act" is part of the COVID-19 response and recovery interventions of the Government;

WHEREAS, Section 4(000) of RA 11494 (*Bayanihan* 2) provides that Procuring Entities (PEs) may directly purchase agricultural and fishery products from farmers and fisher folk and agricultural cooperatives as a form of direct assistance even beyond the lapse of the RA 11469 in accordance with RA No. 11321, or the Sagip Saka Act;

WHEREAS, the Government Procurement Policy Board (GPPB) issued Resolution No. 18-2020 directing the use of GPPB Circular No. 1-2020 dated 6 April 2020 for the direct purchase of agricultural and fishery products from farmers and fisherfolk, and farmers' associations or cooperatives, as provided under Section 4(000) of RA No. 11494 (Bayanihan 2);

WHEREAS, President Rodrigo Duterte signed RA No. 11519, "An Act Extending the Availability of Appropriations under Republic Act No. 11494, Otherwise Known as the "Bayanihan to recover as one One Act" which effected the extension of the availability of funds for the release, obligation, and disbursement for the services and activities provided under Section 4 of RA 11494 (*Bayanihan 2*).
