- 1) Bids must be duly received by the BAC Secretariat through manual submission at the NDA-North Luzon Department, Marilao Office on or before the above-mentioned schedule. Late bids shall not be accepted;
- 2) Opening of Bids on **18 October 2021, 10:00 am** will be conducted on a face-to-face proceeding. Bids shall be opened in the presence of the bidders' representatives who will choose to attend the activity. Authorized representative must have an SPA Special power of attorney.
